to General Personal Jurisdiction in States Where They Are Registered to Do Business

In a case issued on June 27, 2023, a divided Supreme Court decided another important personal jurisdiction case – *Mallory v. Norfolk Southern Railway Co.*, 2023 WL 4187749. The principal issue was whether a foreign corporation that registers to do business in a state will be deemed to have consented to the personal jurisdiction of that state's courts (and correspondingly the federal courts in the state for diversity cases). The answer was a qualified "yes," which suggests that an out-of-state company that is registered to do business in Ohio might be deemed to have agreed to be subject to general personal jurisdiction in Ohio courts irrespective of whether the underlying cause of action has any connection with the state.

Aside from co-use with tobacco, alcohol and cannabis are the most commonly co-used substances nationwide.

Ohio's Justice McLean: The Unappreciated Dred Scott Dissenter

In addition to his stellar service in Congress and as U.S. Postmaster General, John McLean served on both the Ohio Supreme Court and the United States Supreme Court. McLean became the 22nd Justice on the U.S. Supreme Court and served for more than 30 years until his death in 1861. As his biographer explained: "His lifelong battle against the nationalization of slavery by the Court was often futile, but he remained a voice for freedom, however lonely, on a Court dominated by judges who never knew the meaning of their own title—Justice— when it came to slavery and race." See Paul Finkelman, *John McLean: Moderate Abolitionist and Supreme Court Politician* (62 Vanderbilt Law Review 2, 2009). His voice for freedom resonated as one of the two lone dissenters in the infamous *Dred Scott* decision.
