Amicus Curiae Update

OACTA's amicus efforts have started the year off with a bang filing amicus briefs on a handful of influential issues. As always, these efforts have only been made possible by our Board and our Members who graciously write our high-quality briefs for a small stipend. To date in 2025, OACTA filed briefs in four appeals to the Ohio Supreme Court, three on the merits and one at the jurisdictional stage. Each are discussed below.

First, is *Steigerwald v. City of Berea*, Case No. 2024-1077. In *Steigerwald*, OACTA filed an amicus brief supporting Appellant, the City of Berea, and urged reversal of the decision from the Eighth District Court of Appeals. In *Steigerwald*, OACTA asks the Court to find that using non-defective equipment for a governmental purpose (a locker room bench) is not a "physical defect" that can result in a loss of political subdivision immunity under R.C. 2744.02(B)(4). Stephen Funk of Roetzel & Andres, LLP authored OACTA's amicus brief.

Next is One Church v. Brotherhood Mut. Ins. Co., S.Ct. No. 2024-1329. In One Church, OACTA filed an amicus brief supporting Appellant Brotherhood Mutual Insurance Company. In One Church, OACTA asked the Court to reverse the Tenth District Court of Appeals, and find an insured's assertion of "hidden damages," after accepting payment of an appraisal award, does not allow an appraisal to be set aside. Thomas Glassman of Bonezzi Switzer Polito & Perry, Co. LPA authored OACTA's amicus brief.

Third is *Est. of Price v. Kidney Care Specialists*, S.Ct. No. 2024-1373. In *Price*, OACTA authored an amicus brief in support of Appellees, Kettering Physician Network and Latha Venkatesh, M.D., seeking to affirm the decision from the Second District Court of Appeals. In *Price*, OACTA asked the Court to reaffirm its precedent that a trial court has discretion to determine a prospective juror's ability to be impartial under R.C. 2313.17(B)(9). Dan Richards and Kaitlin Madigan of Weston Hurd LLP authored OACTA's amicus brief.

Last, but not least, is *Paganini v. Cataract Eye Center of Cleveland*, Case No. 2025-0386. In *Paganini*, OACTA authored an amicus brief in support of Appellant, Cataract Eye Center of Cleveland at the jurisdictional phase, asking the Court to accept jurisdiction. *Paganini* asks the Court to consider whether R.C. 2323.43's medical malpractice non-economic damage cap for catastrophic injuries violates Article I, Section 16's "due course of law" provision. Benjamin Sasse, Elisabeth Arko, and Razi Lane of Tucker Ellis LLP authored OACTA's amicus brief.

OACTA has also submitted amicus briefs in these appeals, which remain pending:

- Eddy v. Farmers Prop. Cas. Ins. Co., S.Ct. Case No. 2024-0623 (Court accepted review over whether Boone v. Vanliner Ins. Co., 91 Ohio St.3d 209 (2001), applies to attorney-client privileged communications or work product generated during litigation between the insurer and its insured) (Tim Fitzgerald wrote OACTA's amicus briefs; oral argument is scheduled for June 4, 2025).
- Camara v. Gill Dairy, LLC, S.Ct. No. 2024-0064 (whether an employee must show the employer made a deliberate decision not to replace a missing safety guard to establish a rebuttable presumption of intent to injure under R.C. 2745.01(C)) (Kurt Anderson authored OACTA's amicus brief; oral argument took place on March 12, 2025).
- Lewis v. MedCentral Health Sys., S.Ct. No. 2024-0451 (whether R.C. 2323.451(D) allows a plaintiff to amend a complaint to join parties previously named as John Doe defendants but not served under Civ.R. 15(D)) (Tony Brown, along with Richard Milligan and Thomas Himmelspach, wrote OACTA's amicus brief; oral argument took place on March 13, 2025).


In sum, on behalf of the Amicus Committee, I thank the authors who allowed OACTA's voice to be heard in these important cases. Information on other cases OACTA participated in as amicus curiae appears on OACTA's website, which includes a webpage with copies of recent amicus briefs and an Amicus Database with information on older cases.
