OACTA AWARDS PROGRAM

Not all awards will be distributed annually. Members are welcome to provide nominations to the OACTA Awards Committee who will make recommendations to the OACTA Board of Trustees. OACTA Awards will be presented at the OACTA Annual Meeting held in November.

Excellence in Advocacy Award

The Excellence in Advocacy Award honors a lawyer whose career has been distinguished by his or her commitment to effective client advocacy both in and outside the courtroom, professionalism, civility, and community involvement, as well as intelligence, creativity, personality, sensitivity, good judgment, and the education and training of newer attorneys.

Award Criteria: The candidate should be recognized as a highly skilled advocate, effective in resolving clients' legal disputes whether in negotiation, mediation, arbitration, trial or on appeal. A candidate for this award must have practiced law for at least 25 years (or in the case of present or past member of the judiciary, at least 15 years) and should also be a model of professionalism and civility, as well as a leader in his or her community and/or the profession. The candidate need not be still living, a member of OACTA, or currently practicing law.
