Fingerprint Biometrics: Minimizing Risk in the Face of Increasing Liability

Just a few years ago, the thought of employees being able to "punch in" at work using their fingerprint seemed like pure science fiction. Today, fingerprint-based biometrics is widely used as a go-to method for organizational timekeeping.

At the same time, however, the use of biometric fingerprint readers have become the primary target for complex class action litigation under the Illinois Biometric Information Privacy Act ("BIPA"). To further complicate matters, various states and municipalities are enacting new, stringent laws modeled off BIPA to regulate the commercial use of fingerprint biometrics.

It is thus imperative that all companies using fingerprint biometrics take actionable steps to leverage this valuable form of biometric data in an effective fashion maintains compliance with the law and minimizes liability exposure.

Overview of Biometric Fingerprint Technology

Biometric fingerprint technology involves the process of using "biometrics" (*i.e.*, individual physical characteristics) to scan a person's finger and identify their finger "geometry" by measuring its length, width, thickness, and surface area. These measurements are then converted into a mathematical algorithm referred to as a "digital template" or "fingerprint template" and stored in a database.

Fingerprint biometric technology has become increasingly popular; it is now heavily relied upon in a range of different commercial contexts due to its ability to enhance the efficiency, effectiveness, and security of business operations.

But while fingerprint biometrics have produced a myriad of benefits, its use also carries significant privacy risks. Unlike other forms of personally-identifiable information, once compromised, fingerprint

biometrics and other forms of biometric data lose their ability to be used as a secure identifying feature.

Member Request Network

What is it? OACTA's Member Request Network allows you to send and/or request information regarding a court, your opposing counsel, an expert witness, or any substantive or procedural issue to your fellow members, via email, by submitting a Member Request through the OACTA website. Only OACTA members will receive the request.


How can you send a request? Members can send a Member Request by logging into the OACTA website using their username and password. Once logged in, on the right side of the web page is a list of "Quick Links" one quick link is titled "Submit a Member Request" select that link and complete the form. You Member Request is then sent to the OACTA Office to be sent to the entire membership.

How can you search for prior requests? Members can search for past requests by downloading the OACTA Member Request Database. Again, make sure you are logged into the OACTA website with your username and password. On the "Member Home" page you will see a button titled "Download the Member Request Database". This database is updated monthly and goes back two years. Once selected, it will automatically download as an excel spreadsheet. Search the spreadsheet using key words to find an old request.
