

OACTA'S FIRST PROFESSIONAL LIABILITY SEMINAR IS A RESOUNDING SUCCESS

On Friday, June 15, 2012, OACTA's Professional Liability Committee held its first Legal Malpractice Seminar in Dublin, Ohio. Over 40 individuals attended, including attorneys and insurance professionals alike. Attendees of the conference were treated to a smorgasbord of legal malpractice topics including: The Nooks and Crannies of Conflict Analysis; Legal Malpractice Claims: The Claim Counsel Perspective; Boundaries of the Attorney-Client Privilege in the Tech Age: How to Ensure Your Multi-Media Communications Are Protected; Common Pitfalls of Practicing Law - A Risk Management Review; Disqualification of Opposing Counsel in Professional Liability Cases; Addressing Difficult Questions in Defending a Legal Malpractice Claim; and Ancillary Business Practices & Rule 5.7.

Personal Injury Defense Committee Update

Update on Robinson v. Bates Challenges

In May, defense counsel in Moretz v. Muakkassa filed a memorandum in support of jurisdiction with the Ohio Supreme Court. OACTA filed an **amicus** brief in support of jurisdiction over the appeal. OACTA argued

that defendants in tort cases do not need to call expert witnesses on write off amounts under Robinson v. Bates and Jaques v. Manton as long as defendants produce the bills containing the write off amounts to opposing counsel prior to trial in compliance with ORC 2317.421. The language of that statute refers to "parties," which OACTA argues includes more than just plaintiffs.

On June 27, 2012, the Williams County Court of Common Pleas agreed with this argument, and permitted the defendant to introduce write off amounts without calling experts to testify. In [Angeline Brown v. Pamela Black](#), Judge Stelzer reasoned that the defendant complied with ORC 2317.421, and under Robinson and Jaques, the jury could consider both the amount charged and the amount accepted for payment in its deliberations.
