OACTA Announces 2017 Law Student Diversity Scholarship Recipients

Transforming Fact Into Law: Utilizing Ohio's Reasonable Justification Defense to Defeat Bad Faith Claims

Introduction

Bad faith claims asserted against insurance carriers come in all shapes and sizes. More commonly than in other types of civil litigation, bad faith plaintiffs will frequently attempt to concoct wild, exaggerated stories about how "the big, bad insurance company" unfairly, unjustly, and without any rational basis refused to furnish coverage for a claim or provide adequate compensation for a loss. Fortunately, the state of Ohio provides insurers with a robust tool for contesting and combating these grandiose tales of anguish fabricated by policyholders in support of otherwise meritless bad faith claims. Under what is commonly referred to as the "reasonable justification" defense,

insurers can avoid liability altogether by demonstrating that it was "reasonably justified" in its coverage decision that serves as the basis for the policyholder's bad faith claim. Importantly, where the insurer is able to demonstrate the existence of a question of fact with respect to the coverage decision, under the reasonable justification defense the insurer is entitled to judgment as a matter of law on the bad faith claim. If utilized properly, the reasonable justification defense can be deployed by Ohio insurers who find themselves embroiled in coverage litigation to conclusively dispose of almost any flavor of bad faith claim.
